Atlantic Fruit Co. Accident to Boy.

From the "American," Bluefields, we take the following: We have read with considerable interest, articles in Central American and New Orleans papers pertaining to the suit between Messrs. Lindo Bros. of Limon, Costa Rica, and the Atlantic Fruit and Steamship Coy. In one of the New Orleans papers it is stated that the Atlantic Coy. has advanced the price of fruit in Costa Rica four cents gold per bunch. This sounds like good news to us and seems to be the forerunner of good times in the banana industry. It certainly looks as if the Atlantic Coy. intend to pay the the planter what the fruit is worth.

The Atlantic Coy. has been with us a little over 18 months and have at present under cultivation in the Pearl Lagoon district over 3,000 hectares and have purchased about 60,000 hectares of fine banana land. They have practically built the port of Bar Point, have cleared the Kurringwass river of obstructions, have built permanent structures and numerous barracks for its labourers and in addition to these many improvements, they will begin the dredging of the bar at Pearl Lagoon, as soon as the contract and details can be arranged. These extensive operations have done wonders for Pearl Lagoon district and the whole Atlantic Coast and with the immediate prospect of railroad construction by this company their properties will be one of the most important in Central America. In addition to its operations in Pearl Lagoon, the company is very extensively interested in the plantation called "The Escondido Company" on the Escondido river. It is expected that the entire area of 10,000 hectares will be planted and work is going on with this end in view. The buildings erected on this plantation are a credit to this coast and are of a class superior to anything seen on Nicaragua plantations before. The Escondido Company will

be the first large plantation in Nicaragua to be operated to any extent by railroad. All of the above goes to show the confidence that the Atlantic Company has in Nicaragua and its future and it has caused a marked increase in new investments in banana lands. Judging from our experience, if the Atlantic succeeds in getting the same foothold in Costa Rica as it has here, the people there will have every reason to be congratulated.

Hoy es veinte de julio.

Entre las lontananzas de la Historia bate sus alas un recuerdo: el poderío colonial de la vieja España, está herido; el grito de Libertad estremeciendo la cordillera de los Andes, ha llegado hasta las gradas del trono de Aragón y Castilla, llevado por el eterno vaiven de las olas que sobre el Gran Océano unen el mundo de Colón con la vieja Península española.

—A pesar de todos los esfuerzos hechos por el doctor don Miguel A. Velasquez y el Bacterologo del Hospital don Ernesto Machado, no ha sido posible que la Municipalidad decretase, por via de higiene la destrucción del zopilote.

Johnson Win Over Flynn

Jack Johnson, heavy weight champion of the world, met and beat Jim Flynn, the "White Hope," in the 45th round glove contest which came off at Las Vegas, N. M., on July 4th. So heavy was the punishment meted out to Flynn that Capt. Fred Fornoff, for the purpose of saving Flynn from further torture stopped the slaughter at the ninth round at the point of his 44 which he knew spoke louder than words.

FIGHT BY ROUNDS

Las Vegas, N. M., July 4—After the men had discussed the rules with the referee, Ed Smith, of Chicago, time was called at 2.49.

First round—"Will you shake hands Jack?" queried Flynn as he opened the battle by rushing into a clinch. "No," retorted the negro. Flynn kept in close, but Johnson easily avoided his attempts, and flung a stiff left to the ear. The Champion pushed his man across the ring and hooked his left to the ear, and a moment later flung a hard short arm jolt to the jaw. Johnson smiled constantly and fought with great care. Flynn backed the negro against the ropes, and the champion rewarded him with a right that cut a deep gash under his left eye. Round all Johnson's.

Second Round—As Flynn rushed, Johnson simply grasped him about the shoulders and held him at bay all the while grinning like an ape. The champion pecked at the fireman's face with light lefts, and as they clinched, uppercut twice heavily with rights to the jaw. The champion toyed with Flynn, twice more shooting rights uppercuts to the jaw, one of which sent the fireman's head bobbing. The champion this early indicated it was to be a battle of words as well as blows, time and again exchanging his usual repartee with the spectators. Flynn mouth was cut as he took his seat, very much worried during the three minutes of fighting in this round.

Third Round—Flynn cut short a remark of Johnson by twice hooking his right to the jaw. This nettled the negro, and he cut loose with short arm uppercuts to the jaw. Johnson bled slightly from the mouth as he emerged from a mid-ring mix-up and Flynn spat in a stream as the champion cut his mouth with a volley of rights and lefts.

Fourth Round—Flynn rushed in close and was met with the customary rain of right and left uppercuts to the face. At that it seemed as if Johnson was holding himself in check. He shook Flynn with a few stomach taps, scarcely trying to protect his body from Flynn's attacks. Johnson constantly shoved his stomach forward and invited Flynn to blaze away which convulsed the spectators. Flynn elicited a great cheer when he rushed Johnson to the ropes and planted a solid left to the jaw. The round ended with Flynn's face dyed red.

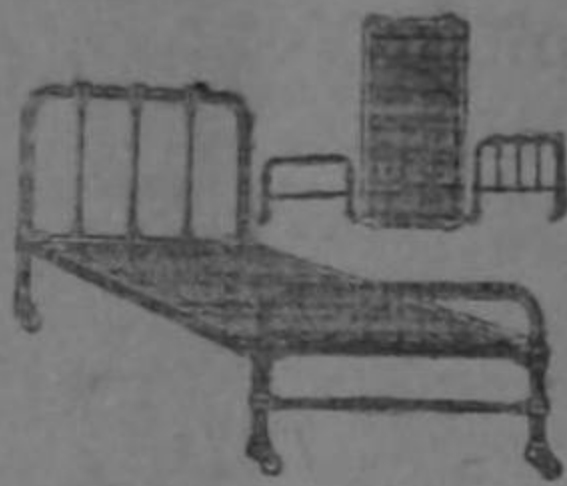
Fifth Round—Johnson turned his head to the spectators and hardly noticed his white antagonist. Flynn banged away at the stomach, but this time Johnson covered up and shot four lefts to the face in quick succession, varying it with a left uppercut to the jaw. Flynn, at close range, sent half a dozen punches to the stomach but Johnson only smiled and again made no apparent attempt to protect his mid-section. Johnson aroused the crowd to merriment by releasing Flynn's hold and clapping his own gloves together like a happy school girl. "I can't fight while he is holding me," shouted Flynn, protesting to the referee. The round ended then, with Johnson holding a running conversation with his wife and seconds.

Sixth Round—Flynn butted with his head three times, and complained that Johnson made it justifiable by holding him. Flynn was severely reprimanded for deliberately butting the Champion. Flynn tried to find a loophole to stem the beating given him. Johnson dazed the fireman with his speed, landing left and right to the jaw. "He's holding me," was Flynn's cry, Johnson angry, landed a volley of straight left and right punches to the face, fairly bowling Flynn then he stopped himself, apparently with a view to prolonging the contest. Flynn's seconds when he sat down also warned him to cease butting.

Seventh Round—Johnson landed fully a dozen rapid fire right and lefts to the fireman's face and at the same time placed himself in a position to withstand Flynn's butting tactics. "Wait a minute," cried Johnson to a spectator who had shouted for him to end it. Flynn bled profusely from the nose as Johnson beat a tattoo with right and left to that organ. Flynn failed to land a glove on the champion, the negro's defence proving impregnable. Johnson made a geyser of Flynn's nose as he rained blow after blow on his bewildered opponent. There was not a spot on Johnson as he took his seat.

Eighth round—Flynn tried to butt again, but was warned. The round was very much like its predecessors, with Johnson uppercutting and Flynn butting viciously at the same time losing much blood. Flynn was helpless in the champion's hands and for the tenth time in this round was warned, the referee adding, "Once more and we will disqualify you."

Ninth Round—Johnson held the fireman at arm's length in an attempt to guard himself against the fireman's constant butting. Flynn finally got in close, jumped a foot in the air and landed with the top of his head against Johnson's jaw. Fred Fornoff, Captain of State Police realizing that the referee seemed loath to end the contest on a foul, jumped into the ring and brought the battle to an end. The referee thereupon gave the decision to Johnson. Johnson was given a terrific cheer while the crowd wended its way out.

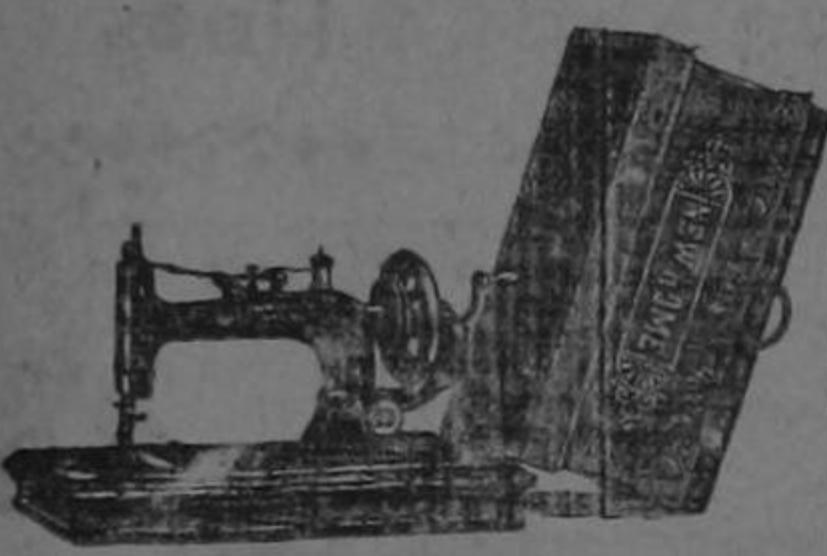

DANGER THREATENED!

Experience has taught us that the ownership of any thing that is to be valued sincerely must be obtained at great deprivation to some one. Consequent on the attempt at competition in the country we see every effort being used against the small farmer to compel him to wear the yoke of the old company. Around Limon we find every foot of land which has been occupied by the petty agriculturalists for years indeed decades of years, has been thrown into the hands of the United Fruit Coy. in some way, shape or manner. There are dozens of agriculturists who up to now thought they were perfectly independent, having cultivated these lands for periods of years, varying from ten to forty years some even having registered titles, now awoken to find that as a result of an attempt to help in competition, are they shown supposed documents by Mrs. Dora Pucci thirteen years ago, others by Don Gerardo Echevarria, when no one seem prepared to explain.

Hence it is evident that several people seem to have obtained titles for the same pieces of land

These are therefore matters for the Government to investigate for the honour of the legal profession of the country; that one lawyer should intentionally or otherwise mislead his client to make documents for a property that has already been recorded in the Public Records seem so far away from reason that the Legal Committee would prove themselves heroes in the moment, so that even tho' we lose we shall feel satisfied by the punishment of those guilty of fraud and competition would have served a double purpose.

Opinions Expressed.

We beg to acknowledge a number of expressions of appreciation of the Editorial in our last issue entitled: "Is the U. F. Coy. a Trust in Costa Rica?" We have a good deal more to say along this line and we propose to say this in due course. We here state explicitly, that so far as we are concerned there is no personal feeling in this matter, and any one asserting the contrary will be placing himself in the way of forcible denunciations.

Explanatory.

Mr. Editor: Sir,—While thanking you for the prominence given to a weak effort on our part—a prominence which we really do not merit—we should yet like to make a few necessary corrections. You are misinformed. We are in no way connected with any movement in the United States. Dr. Boyd has no more to do with our effort here than George V. To our best

knowledge there is no such organization among the coloured people of the States as the "Pan African Association." Dr. Boyd is at the head of a great "Publishing House, Globe Co." etc., and to cite him in this connection is as relevant as citing the Editor of the Times. We may further state that the Baptist Pan-African Literary Association is to high-sounding for us. We are of low estate Relative to my position with the Literary and Friendly Society of Limon, I may state that I understand that in my absence I was elected to an office, but I do not remember having "agreed and then declined." I did nothing of the kind. We are doing nothing in antagonism to the Literary and Friendly Society, nor are we conscious of the slightest act of discourtesy to them. Our attempt is in no wise confined to the Baptist Denomination, therefore is in no way Baptist. I am etc., Wm. Forde.

In view of the above, we are sorry that our information has been incorrect, but it was obtained from a member of the Association, who told us that the name was the Pan African Literary Association, and that the intention was to enable young men to save their money to go or send whom they care to Dr. Boyd's Institute to study on similar lines with the Tuskegee Institute, hence if the information is wrong, it must either have been so given by those in a position to impart it, or those receiving it was in error when receiving it.

We were also told by some of the members of the Pan African Association that the Limon Literary Association was a selfish one as it only accepted men of a certain class to which we replied that the requirements as we understand them, only insists on respectability and intelligence, and if the Pan African Literary Association do less, we will be sorry for them.

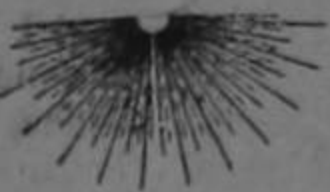

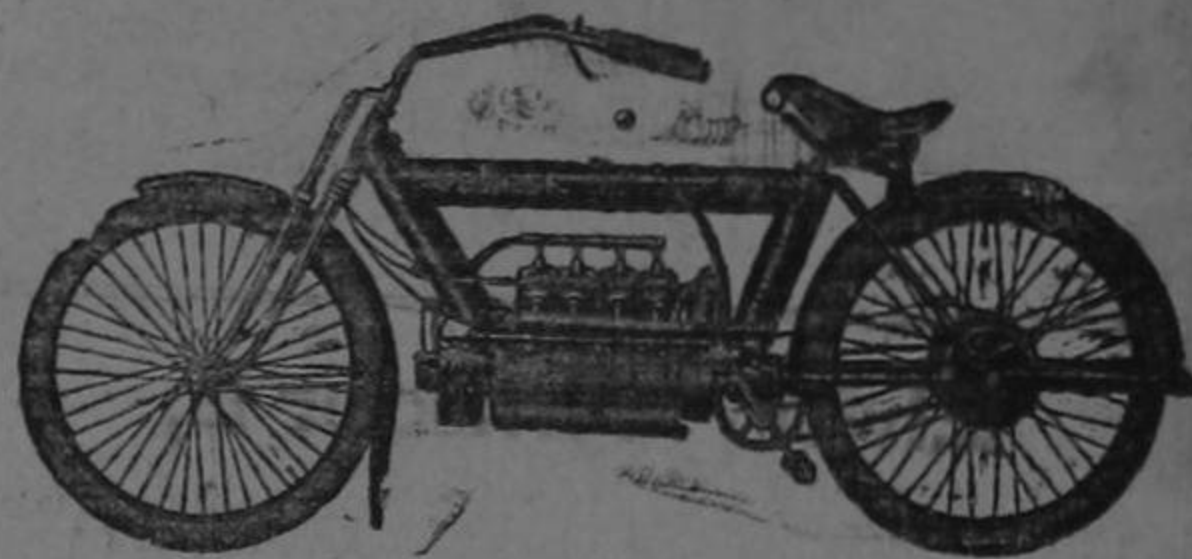
