'La Republica's' Idea Of The Compromise

The following is copied from "La Republica."
The Editor of "La Republica" opens in the editorial firstly by saying he has kept quiet ever since the start of the Atlantic Fruit Coy's operations here, watching developments, and that for several weeks now he had proofs in hand to throw light on the matter but he was waiting for one more such to have convincing testimony which has just arrived.
"The Atlantic Fruit Coy. arrived in Costa Rica with the pretext that she had come to carry into effect a great transaction claiming as theirs the farms of Lindo Bros, representing a value of 3 1/2 million dols., and had naturally to find out what sort of service would be afforded by the Railway and Wharf in the regular exportation of fruit, which was very correct on the part of the Coy, but a while after we found that the claim was informal from the fact that the claim was not accompanied by the price of the farms. We later heard that the Coy. was willing to do business at first for a big sum, but later, for an insignificant amount, an amount hardly enough to cover the costs of the lawsuit.
The Atlantic has done good business, she has crowned her efforts: by the publication of a few advertisements, by a few protests before the Government and before the Tribunals, it has received 100,000 dols. Very good speculations!!
These facts all go to prove the truth in the statements of Mr. Cecil V. Lindo, Agent of the firm of Lindo Bros, that the Atlantic did not seriously intend coming to Costa Rica and had no right to establish such an action.
We may very well understand that notwithstanding that the Atlantic could not sustain the litigation, yet Messrs Lindo Bros. prefer to pay 100,000 dols. to close the suit. It will readily be seen that from the magnitude of their business and the difficulties in the way of a financier having a capital pending for several years before a Tribunal are sufficient reasons to sacrifice this sum. The firm of Lindo Bros. who possesses the development of the greatest agricultural possibilities of the country could not induce foreign Bankers to invest in their business meanwhile they had a lawsuit hanging over their heads of 3 1/2 millions. The Atlantic knew this well, and for this reason they took the chances, although they knew they had no right nor could they carry out their part of the obligations.
The arrangement on the part of the Atlantic is unparadonable, and as a gentleman who has lived here for many years describes it: "it is the action of a vegetable seller,"

and we feel it is nothing better, with grave ridicule to the Government and the Tribunals of the Republic to whom the matter has been taken as a pretext.
There is nothing to justify the actions of the Atlantic Fruit Co., claiming the aid of Costa Ricans, exciting their patriotism, asking help of the Government, running to the Tribunals of justice to make good headway in their speculation, is unheard of.
It is necessary therefore that the country knows the conduct of this company here and abroad.
We today reproduce an article published in Santa Marta and Barranquilla in which are related certain proceedings of the Coy; and we make these reproductions so as to avoid surprises.
Barranquilla, June 29th 1912
Senores Lindo Bros, San Jose.
Dear Sirs:—I have read a Bulletin, published by you there relative to the vexatious affair with the Atlantic Coy, and as I consider that certain clippings from "El Pueblo" may be interesting to you, I forward them here they are badly left, as you will see from the clipping which is perfectly correct.

Clippings from "El Magdalena" of Santa Marta, 23rd June, 1912 and reproduced by "El Pueblo" de Barranquilla of 28th June, 1912:
For several months now it has dawned on us that the options for purchasing banana farms were not destined to a Syndicate or group of French or English men, but to the Atlantic Fruit and Steamship Coy., a Yankee Fruit Association, we remember that a writer (we do not know if it was in "El Pueblo" or in another journal), advised the owners of banana farms, that if they made any business at all, it must be spot cash.
Imagine the deception and surprise to the producers when they know, and particularly those who directly notated their contracts with the U. E. Coy. on account of men of straw, when they knew as we say by the documents they had signed that the price of the farms was not to be spot cash, but by drafts at 30 days drawn by the purchaser, who was not the Atlantic Fruit Coy, but Mr. Joseph Di Giorgi in his own name however they all remained in the certainty that at the end of 30 days (which is not much in this mortal life) they would receive their money but before the time arrived Mr. Charles Pringle who was left with the Power of Attorney of Mr. Di Giorgi, quietly disappeared one night without even saying to anyone, there are my keys, he left them on the Av. bingia of 16 June.
Although he knew at that time that the Commercial Bank of Barranquilla which had discounted some of their checks naturally showed signs of great

Lucha de las Compañías Bananeras No obtiene La United Fruit Company apoyo de la justicia El fallo de los tribunales norteamericanos

Publicamos á continuación una traducción muy interesante con respecto á los ballos procederes de la United Fruit Company en Santa Marta. Por ella se verá que aquí, como en todas partes, los señores del banano proceden de la misma manera, y que aquí como en todas partes son un peligro para los agricultores nacionales, y un peligro para la soberanía del País. De esto último ya tenemos algunas pruebas por aquí, pésele á algunos diarios de San José.

El señor Di Giorgi declara violada la Ley Sherman por sus antagonistas. Exportación de bananos de Santa Marta.

Nueva York, Julio 13.—La Atlantic Fruit Company registra un nuevo y señalado triunfo sobre la United Fruit Company ó sea el monopolio de fruta. La victoria declaróse á favor de aquella en la Corte de Justicia del Distrito Federal, al negarse el Magistrado Lacombe á dictar providencias, según pedía la United Fruit Company, que impidieran á la Atlantic Fruit Steamship Co y á sus distribuidores Joseph Di Giorgi y Salvatore Di Giorgi, principales de esas compañías.

Importar bananos de Santa Marta, Colombia, y vender la fruta procedente de ese lugar. Desde hace muchos años esa región vivía bajo la férula de la United Fruit Company en cuanto se relacionaba con el embarque de frutas.

Aunque solo se pedía del tribunal

una acción preliminar, no obstante eso le fueron presentados todos los documentos de ley con los datos necesarios y el asunto se discutió ampliamente ante el Magistrado Lacombe.

Pese á los muchos esfuerzos de la United Fruit Company en Santa Marta por sostener allí su monopolio, tal ha sido la decisión de los cultivadores en sostener nuestra competencia, que las remesas de bananos, recibidas por mi Compañía en Nueva York, han llegado á ser iguales, últimamente, á las de la Compañía Rival y en cierto modo superiores. A los rudos ataques que nos dirigió la United, ante los tribunales, respondimos que siendo ella una compañía monopolizadora está en abierta oposición con el Sherman aquí y carece por consiguiente de títulos para pedir apoyo á un tribunal equitativo.

Procediendo al fallo del Magistrado Hacombe, vimos en la prensa, varios avisos de la United Fruit Company, en que refiriéndose á la formación de la Magdalena Company, creada por los jefes de la Atlantic, para entrar en posesión de las fincas de Santa Marta, declaraba ser en virtud de contratos celebrados, dueña de cuanto fruta produjeran las fincas en cuestión y prohibía, al mismo tiempo, á los compradores en perspectiva, hollar sus pretendidos fueros.

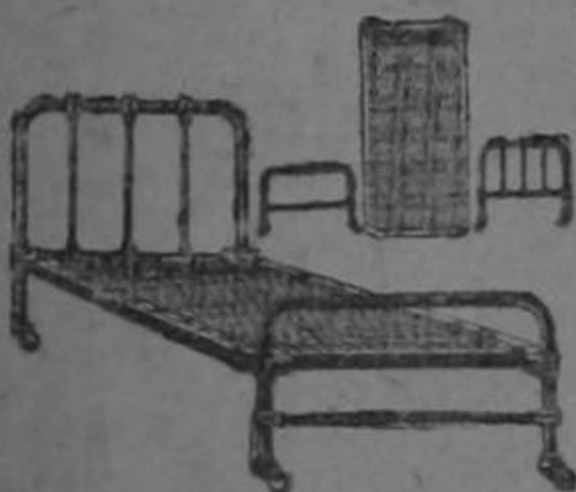

disquietude. In the meantime urgent despatches arrived from Barranquilla giving the alarming news of the protest against the cheques, all of which news were rejected by the admirers of the Atlantic who believed in the power of the Company, like a writer of Rigoletto, saying in a few days she would pay up in hard cash. Yes everything, but the price of the farms bought. At the arrival of the Ideal of 21st all debts were removed. Mr. Di Giorgi, the genial financier, plainly confessed that neither himself nor his powerful Company had the money with which to pay the prices, neither in 30 or 90 days or ever because it was at their instance that the first draft was protested. In what other country in the world, would this not be considered a declaration of bankruptcy. The same proposition that Mr. Di Giorgi brazenly made to the mad headed vendors, who so foolishly passed the ownership of their properties to unscrupulous people who were so down in the gills that they could not find 77,500 dollars, proves the quality of salveancy of the powerful Atlantic. Mr. Di Giorgi offers to pay 33 per cent cash and the balance of the price within three years. Assuring the balance with a mortgage on the farms. There is no more for the sellers, because the administration and reaping of the farms belongs to him. Clearer confession of bankruptcy could not be made. If this is not the greatest robbery or fraud with one's eyes wide open, what is? A terrible must have been the deception of the vendors to find themselves cheated and wrapped to a nicety by unreasonable speculators, aided by people of the country. Is this the protection that should have been given to the producers of Magdalena? what protection can people or societies, give without the capacities of insignificant sums of money in the market of New York? Because surely if the cheated producers accepted the propositions of Mr. Di Giorgi, which appeared fresher than a lettuce and more cunning than the aligators of the Mississippi, they would be doing it as a drowning man accepts a line. The probability is that not even the so much per cent which he offers today would be paid in cash, and now we can the more appreciate the wise proceedings of Mr. Lindo in breaking off with these people of the Atlantic. Where these people went to reap millions in a place where they could not get not even the value of their first draft. Leaving to us laugh heartily at the folly of adventurers who neither bring honour nor enjoyment, since even the value of the fruit is lost.

It seemed so painful to us to believe that men like the principal sellers, who by their pecuniary position could lend money to the clever Di Giorgi, would so humble themselves as to be mandadors for this Americanized Italian, because he has had the skill to earn large farms without a dollar. We are led to believe that Christian resignation was intended for other purposes. Men of honour esteem their general dignity and do not lend themselves to be the instruments of those who are only so by

Banana Industry.

Oh! if one would but follow the advice that honesty is the best policy. This deep word was expressed by an American whose name is respected in both worlds, but the sayings of Washington has been set aside to respect those of Di Giorgi, hence this result. And after all what is the attitude of the "man of straw" will he also have suffered in the catastrophe? Might he not be deemed a rogue? "Il ne lâura pas volé."

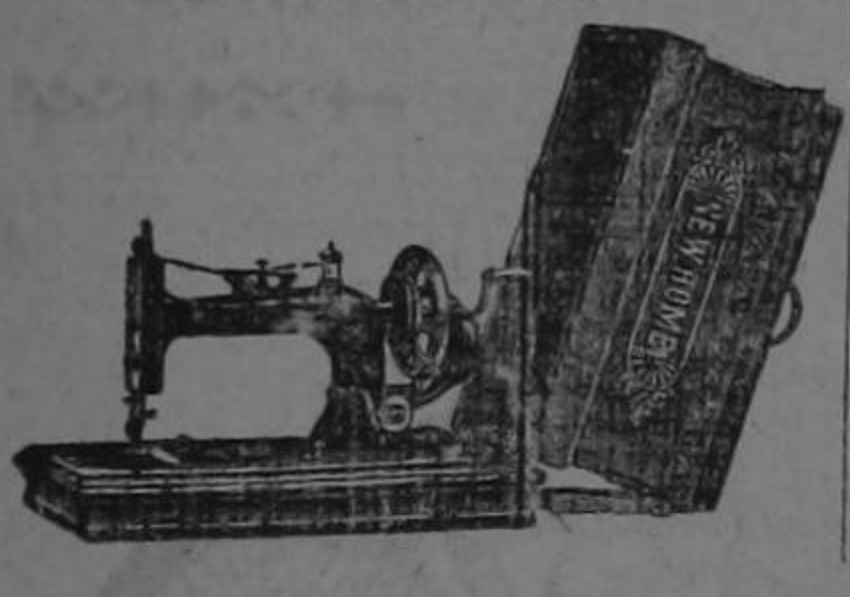

THE CONDUCT OF THE ATLANTIC.

We have produced at the request of some of our readers, a very long article from "La Republica" on the conduct of the Atlantic both here and in Santa Marta in the banana business.

We must however admit that we cannot follow the reasonings of the above paper, that is of course calculating that she would argue impartially solely in defence of the prosperity of the country.

In the first instance he quotes the "Magdalena" which seem to have a direct spleen against Di Giorgi and the Atlantic, as is evident from the personal abuses showered on them both by that journal, whereas the "Voz of Santa Marta" which seem to argue pro and con, quotes "El Comercio" in saying that the farmers had a meeting among themselves, and at this meeting it was resolved to accept the propositions of the Atlantic, that is, to receive 40 per cent of the value of the farms in cash and the balance in 3 years by yearly instalments, during which time the farmers will continue exploiting the farms and selling the fruit to the Atlantic for cash at full prices. Now this seem a very fair proposition, and if the Atlantic had come to Costa Rica with a similar proposition we are sure they would have obtained all the farms they could handle.

The "Voice of Santa Marta" in her apparent impartiality, goes on to prove that the U. F. Coy shipped for the month of June 347,230 stems of fruit, whereas the Atlantic shipped 79,242.

"La Republica" says that the compromise of the Atlantic with Lino Bros. is the action of a vegetable seller, but here also we fail to agree with her, as "La Republica" fails to remember that the glasses through which the Atlantic saw the farms of Lindo Bros. formerly, are not of the same intensity today.

The value which were placed on those farms formerly by the A. F. Coy. are not the same placed on them now, although they may have risen in the market as is evident by the amount of mortgages said to be put on them since, yet considering that the A. F. Coy. can get 10,000 hectares to cultivate, is it likely that they would jump at a thing they could not touch for 2½ years when there is the possibility for doing better?

"La Republica" also says that the compromise has been made for a very little more than the price of the lawsuit, this proves that they have made little or nothing by it, it seem only a matter of getting out of a bad bargain. Anyway we look at it this way, if by the compromise, and if by the embargoes put on their fruit, the Atlantic has been forced go to the Paraisina Valley to develop that section of the country, we are glad all has been accomplished. Mr. Wetmore goes to the States to get the orders of his Directors how best to develop the Paraisina Valley, when he returns, the country will have benefited by all the struggles. And in the meantime, in view of the figurings of the different Coys. The Xrinachs, the Atlantic, the Lindo, and the U. F. Co. it would be well that

the hint thrown out by the Costa Rica planters take Umlungu some time ago, and form a league among themselves and hold meetings for their mutual good.

The Seeds Of Gentility

At the funeral of our much esteemed fellow citizen, McCutchen, on Wednesday evening, we observed two Jews in the audience over the grave, one conducted himself perfectly gentlemanly (as he has always been), meanwhile the other behaved himself most stupidly turning his back to the Priest at every mention of the name of Christ, and apparently trying to distract his attention from the ceremony. We wondered why was he present? Surely this is not the first Christian burial service he has ever heard, therefore if he did not care to listen to the ceremony, there was no compulsion in his presence.

By your fruits shall ye be known.

Misconduct In Court.

Is it true that one of the biggest chiefs of the U. F. Coy. was asked to take a step outside the Courts Office for his presumption, a couple days ago? It is said that he tried to dominate the office as he does the banana fields between here and Zent, but he was made to understand that neither his size nor the size of his Coy., made any difference with the means of justice here.

Tax on Real Estate

A project has been put before Congress by Dr. Hernandez with the idea of placing a tax on landed property. Mr. Hernandez tried to prove that the rich do not contribute justly in proportion to public funds, as is borne out by the assertions of Dr. Duran in consequence of which he advocates direct taxation on landed property from which they draw their wealth. He asked therefore that a Commission be named to consider the matter by the Executive.

Heavy Mortgages

We observe that the U. F. Coy. has put on some very high mortgages on the farms bought recently by the firm of Lindo Bros. and which were said to have been turned over to the U. F. Coy., when the A. F. Coy. refused to take them in the option. The mortgage is for one and a half million dollars gold.

The farms included are: Bronstorf, Gayle's House, Alemania, La Corona, Livingstone, Isla Chanchos, Canada, Monte Chisto and La Isla. On Isla de los Chanchos, the amount of mortgage is 400,000 dollars or the full value, in fact more or less they are mortgaged right up to full value. The transaction is significant.

LETTER TO MR. O. OWENS

The Concession.

"La Information" has it that the Atlantic Fruit Coy. has notified the Government that in consequence of the various obstacles and difficulties which have been put in the way in the exportation of fruit by the Company, that the Directors had resolved to desist in this business, and to ask that the work of the Commission be brought to a close.

The same paper says that the Commission is preparing its report to be presented in a day or two, and that it proves that there is no surplus of bananas not contracted by the U. F. Coy, which the growers could not sell to another Coy. It goes on to say that the Government has made a concession with the Atlantic Fruit Coy., giving them 10,000 hectares of land in the Tortoguero Division to be planted in bananas, provided that a waterway be made between the lagoons and the rivers there, and that a port be formed in that locality. It is thought that the scheme has interested the Directors in New York very much.

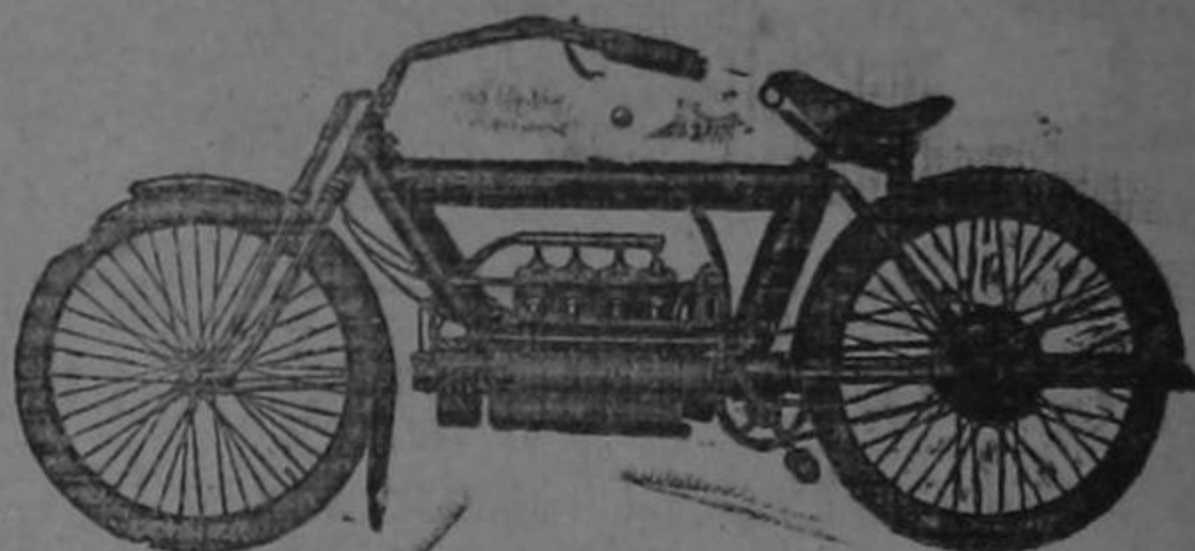
