The halfway mark of the 4-year European Recovery Program, known as the Marshall Plan in honor of its originator, General George C. Marshall, was observed in ceremonies in Washington, D. C., on April 3, 1950. General Marshall, who first proposed the program in June 1947, when he was U. S. Secretary of State, was the principal speaker. Addressing an audience of 1,200 persons, which included representatives of the ERP countries, members of the U. S. Congress, officials of the U. S. State Department, and staff members of the U. S. Economic Cooperation Administration, which administers economic aid to Europe under the recovery program, General Marshall cited European recovery progress thus far as a "near miracle" and asserted that "we must carry this battle to the finish." Also taking part in the ceremonies were Economic Cooperation Administrator Paul G. Hoffman and U. S. Secretary of State Dean Acheson.

STALIN'S SEPARATE PEACE IN 1943

— Continued from last issue —

Hitler reacted evasively to Mussolini's suggestion at that time, partly because he had misgivings about the Italian's

ability to handle such negotiations discreetly, partly because he still clung to the hope that the luck of the German armies in the East would change.

III. A few weeks later surprising reports came in from Japan that the Russians were open to proposals for a separate peace with Germany. Japanese government changes were under way at this time, and the Nippon authorities had just prevailed on the Soviet Union to renew their fishing agreement. Japanese General Staff officers had let it be known through the German Naval Attache in Tokyo that they had

definite information that the Soviet Government was inclined to consider a separate peace with Germany. The Japanese press also carried a discussion of the possibilities for an understanding between Germany and the Soviets.

Ribbentrop conferred with Hitler several times in the course of 1943, on this subject and told him also of these reports from Japan. With the increased successes of the Allies, Hitler warmed to the idea of a separate peace, but was hesitant about responding to peace feelers because he feared indiscretion on the part of the negotiators, and was above all concerned lest the morale of his generals and troops in the East suffer.

The Stockholm Incident

IV. Early in the summer of 1943 rumors developed in neutral Sweden as to the possibilities of a Russo-German understanding. There are strong indications that they emanated from the Russian Embassy in Stockholm. Madame Alexandra Kolloray was the Soviet Ambassador to Sweden. V. Semionov, who later played a leading role in the Soviet occupation authorities in Eastern Germany, was her Embassy Counselor. On the German side there were in Stockholm, addition to the regular Embassy staff, numerous agents of Admiral Wilhelm Canaris military espionage organization who tried vehemently to split the Allies. Walter Schellenberg's notorious Sixth Department of the Gestapo also had its confederates and go-betweens there.

One of the most active go-betweens in Stockholm was a businessman by the name of Josef Claus, who was originally from the Ukraine, but had lived for a long time in Sweden. He had established connections, dating back to the outbreak of hostilities, both with German military agents in Stockholm and with Russian Embassy personnel.

When Foreign Minister Joachim von Ribbentrop heard of the possibilities of a separate peace and the Claus contacts, he immediately sent to Stockholm one of his most trusted men, a former employee of Ribbentrop Bureau, who was later appointed, to a high post in the German Ministry for the East. This agent, Peter Kleist, traveled under the pretext of conferring with the Swedes on settling a group of Estonian refugees in Sweden. In Stockholm Claus and Kleist contacted each other at once and discussed the possibility of a separate peace. Claus then talked things over with his friends of the Soviet Embassy. Neither let it be known to what extent he was empowered to act on behalf of Berlin or of Moscow. According to trustworthy German witnesses, Claus delayed giving an answer to any German inquiry until his secured instructions from Moscow. (To be continued)

ILO: BATTLE FOR UNION RIGHTS

In a bold move to protect workers throughout the world in their right to organize, the International Labor Organization last month created a Fact-Finding Commission of Freedom of Association. The nine-man commission will investigate infringements of trade union rights, anywhere in the world—but only with permission of the government concerned. However, if the ILO believes a complaint should be investigated, and permission is withheld, it is prepared to take alternative action. This would include publicizing the charges made, the comments of the government, and its refusal to cooperate in getting at the facts and conciliating the issue. The commission will hear views of workers' and employers' organizations and government, in its effort to adjust difficulties by agreement.

ILO expects far-reaching results from its recent Asian Regional Conference in Ceylon. Sixteen resolutions of the Conference are now before the ILO Governing Board. They include proposals that the Asian Governments establish wage-fixing machinery to protect workers, labor inspection, employment services and vocational and technical training. These are seen as first steps in plans to make full use of Asian manpower, in order to "root out and heal the ills of poverty, disease, famine and ignorance". The words are those of David A. Morse, Director General of ILO, and he adds that this is "the surest and really the only road to world peace".

Reformation Decreed Law No. 788 of November 2, 1949

The law to regulate the relation between the producers and exporters of banana,

Article 1: The relation between producers and exporters of banana in the territory of the Republic and which is not regulated by contracts with the States remain subjected to the present law.

Article No. 2: To attend to the compliance of this law, such as to regulate the business to buy and sell banana for exportation; to agree with that which is herein disposed to create a Banana Board or Committee to consist of 5 persons of which three will be the free appointment of the Executive Power; one of these will be the chairman of the Board. The other two will be appointed by the Executive Power by asking for tenary number of the exporters and producers of banana. In addition there will be named in the same form a suplente expressly determined for each one of the members of this Board and will act with power in the absence of the member of the Board. The members of this Board will merit daily salaries in the ordinary sessions whose total will be figured by the Executive Power. The Board will meet ordinarily once per week and extraordinarily each time one or more of its members solicit. The quorum of this Board is formed by five members. In the absence of the members of the Board whose excuse must be

presented to the chairman in oportune time to enable him to fill the vacancy with the suplente according to the regulation decreed.

Article No.3: The members of this Board will have a term of two years and can be re-elected.

Article. 4: To be appointed a member of the Banana Board the following is required:

(a) To be of legal age and an exercised citizen.

(b) To be a person with recognized honour and with experience in banana activities or any business or company of any nature.

(c) Not to be an authority or an employee of public powers.

Article No.5: The resolutions of the Banana Board will be appealable within five days of its approval before the Ministers of Agriculture and Industries, Economy and the State, according to the nature of this disposition which must be decided within the following eight days:

STRANGE HAPPENINGS IN CHINA

MILLIONS FACE DEATH

Chinese farm families 40 miles outside Peiping began eating grass and tree bark late in January as the only means of keeping alive, according to recent news from North China.

This simple fact underscores the extent of the suffering now rapidly spreading through 11 of China's most populous provinces. Letters from travellers and delegations seeking help are reaching Hong Kong. They tell of growing mass starvation on a scale difficult to comprehend.

Indirectly and belatedly, Communist officials are partly admitting the scope of the disaster.

Observers, diplomats and missionaries are revising upward their previously estimated over-all possible death toll this spring of 10,000,000 person.

It is now reliably reported from Peiping that in surrounding Hoph province alone 2,000,000 die.

Recent reports indicate that starvation will extend from the traditional famine belt of the lower Yellow river plain into the northwestern province of Kinsu. Letters from Yangtze valley, where the worst flood in 18 years last summer damaged

only one famine area of southern Shantung and northern Anhwei and Kiangsu provinces. It is semiofficially estimated that 32,000,000 persons were «off the grain diet» a month ago. Off the grain diet means they were without rice, wheat, millet and similar staple foods on which the Chinese depend.

FAMINE FOOD

Until early next summer these people will have to try to sustain life on leftover salted vegetables, turnips, beans, sweet potatoes and the like in some sections these will soon be consumed. Thereafter most farmers will be largely reduced to eating the traditional famine food of mud mixed with grass and bark roots.

Observers, diplomats and missionaries are revising upward their previously estimated over-all possible death toll this spring of 10,000,000 person. It is now reliably reported from Peiping that in surrounding Hoph province alone 2,000,000 die. crops, tell of widespread suffering.

SUICIDES REPORTED

Suicides due to lack of food are reported from several districts in Kiangsi province. In sections of Hunan and Kwang-

tung provinces, farmers are eating seed rice which should be planted to produce next summer's crops

Chinese Communists are reportedly ruthlessly mobilising their available resources of party cadres to fight the famine.
