## EL SINDICATO de Pequeños Productores pide al Gobierno la finca Barmouth

El sindicato de Pequeños Productores de la Provincia de Limón, pide por este medio al señor Presidente de la República haga efectivo el acuerdo de la Municipalidad de este Cantón en lo referente al terreno de la finca Barmouth que es propiedad del Estado, ya que la Municipalidad ha renunciado a los derechos que tiene en las mejoras en favor de los trabajadores Campesinos, esta finca sita en Distrito Segundo (Matina) tiene mil hectáreas, está dada de viviendas, carros tranvia etc., considera el sindicato que es urgente que el Gobierno de don Teodoro Picado resuelva dar los derechos de dicha finca a los afiliados de Pequeños Productores, el plan de Hacienda del Congreso comprende este punto, distribución de tierras, en este caso no tiene el Gobierno desembolso alguno, sólo la redacción de un decreto Legislativo y manos a la obra, los Regidores Hernández y Picado han renunciado al señor Gobernador por medio de una nota que, están siendo destruidos los árboles de hule por personas inespertas, esto no sólo está causando un grave daño a la destrucción total de estos árboles, sino que están siendo explotados por individuos sin derecho o permiso alguno, para la organización de esta finca es necesario que el sindicato tenga absolutos derechos, y estos sólo deberá darlos el Gobierno, como base para el desarrollo agrícola y producción de artículos de primera necesidad en esta zona está esta finca, gran cantidad de maíz ha salido este año producido en Barmouth manifiestan trabajadores que han cultivado en ella que bien puede producir arroz y frijoles y de muy buena calidad, y si este es el empeño del actual Gobierno, también lo es el del sindicato, queremos aprovechar esta oportunidad para recordar una vez más al señor Ministro de Agricultura la solución del problema de los Campesinos de Zent, se ordenó levantar una información respecto al tranvía de Chirripó y los medios de transporte para estos campesinos, tenemos informes que hasta el momento

no ha habido ninguna resolución ni información alguna, mientras tanto estos trabajadores siguen afrontando su situación, en el ramal la Estrella, en el lugar llamado Penshurt, se está reconstruyendo el ramal del Tranvía que conectará Cahuita con Penshurt, este trabajo lo está haciendo la Compañía United Fruit Company, por informes que se han suministrado el trabajo se está ejecutando con materiales de inferior calidad, los rieles que se están poniendo no son de buena calidad y que están muy malos, los polines que se están

usando son los mismos que tenía esta vía, las platinas están en mal estado, la verdad es que dentro de muy poco tiempo no servirá de nada esta vía, nos hemos dirigido al señor Ministro de Agricultura para que corrija con tiempo este mal, ya que se están invirtiendo una fuerte suma para dotar a esta región de una vía que le dará vida a la Agricultura. Esperamos que todas nuestras razones sean consideradas para provecho de Costa Rica.

## NO ES EL GOBIERNO AMERICANO QUIEN REBAJO CINCO CENTIMOS EN EL PRECIO DE COMPRA DE BALSA

Son los contratistas quienes lo han hecho obligados por la competencia

En nuestro número anterior al dar la noticia de que se había rebajado cinco céntimos por pie en el precio de la balsa, dijimos equivocadamente que era el Gobierno de los Estados Unidos.

El gobierno americano no tiene ninguna ingobernabilidad en este asunto. Fijó simplemente el precio máximo para la venta en los Estados Unidos, y presta su ayuda a los contratistas con maquinaria y facilidades de embarque, pero no interviene en los precios de compra ni de producción, que queda a juicio de los empre-

sarios que lo exportan.

Lo ocurrido, según hemos podido enterarnos es que el gobierno americano tiene ya suficiente stock de balsa y ha permitido a los contratistas la venta en plaza a los particulares. Por este motivo la producción que de estos países se embarca para la república del norte, y que es enorme, ha tenido que ofrecerse en plaza y ello originó una rebaja del precio inevitable. Pero como repetimos el Gobierno de los Estados Unidos no ha tenido ninguna intervención en la baja del precio.





ANGORA, 4 UP. — Informaciones privadas dicen que Bulgaria, Hungría y Rumanía rehusaron la petición alemana de romper relaciones con Turquía. Aparentemente animados por la valiente actitud turca contra Alemania y sus satélites bálticos rechazaron la petición alemana de romper relaciones con Turquía debido a su coadjutorial amistad con su vecino balcánico. La mayoría de los círculos creen que Bulgaria y finalmente Hungría y Rumanía pronto intentarán retirarse de la órbita de influencia alemana y harán la paz con los aliados. Tíenece entendido que Marco Balavanov ministro búlgaro en Turquía visitó la semana pasada al primer ministro Saragog y aseguró su alta estima y amistad. Kurihara visitó Saragogú lunes y las informaciones dignas de confianza dicen que informó que Japón no veía razón para romper relaciones. Musaffer Gér, embajador turco ante el Japón visitó el miércoles Kurihara antes de partir al día siguiente.



## NOTAS EDITORIALES

**LA PROVINCIA DE LIMÓN Y EL BANCO DE SEGUROS**

**El señor Sub-Gerente del Banco de Seguros** estuvo en Limón el miércoles último. Traía la misión, según nos dicen, de adquirir el edificio contiguo al Teatro Arrastre para instalar allí el Cuartel de Bomberos (bombas, club y habitaciones para el personal voluntario).

Nos parece mala la elección del local y mal la también la política seguida por el Banco con relación a la provincia de Limón.

Malo el local, porque se ha escogido un edificio que está contiguo al Teatro que es uno de los sitios más concurridos de la ciudad. Allí es naturalmente donde mayor cantidad de gente se estaciona. En el momento en que las bombas tengan que salir precipitadamente como tienen que hacerlo a la hora de una alarma, no podrán desenvolverse y maniobrar con facilidad por el inmediato peligro de un accidente. Tampoco el local es a propósito y habrá que hacerle muchas reparaciones para que en definitiva no llene las necesidades que se buscan.

En cuanto a política del Banco en relación con esta ciudad resulta mala porque la compra de ese edificio indica el deseo del Banco a no hacer inversiones de importancia en Limón, no obstante que el columnen de sus negocios en esta ciudad es bastante cuantioso. Parece justo que por lo menos una parte de lo que aquí pagamos para el Banco vuelva a invertirse en esta misma ciudad. Desde hace muchos meses se le ha solicitado a la Directiva del Banco la instalación de una sucursal que tenga las comodidades y la importancia que requiere una institución de esta clase. Esta sería la oportunidad de resolver estas deficiencias.

El Banco que es una institución nacional está obligado por la propia ética de sus funciones a mantener una política de absoluta igualdad en todas las provincias. Nosotros aplaudimos sinceramente la obra que el Banco de Seguros está desarrollando en beneficio general. Sus inversiones en las empresas de fomento. Su apoyo económico a la agricultura y a la industria demuestran un noble empeño de la Directiva y sus gerentes en el bienestar nacional. Pero no podemos aplaudir que ella sea exclusiva para la mesa central cuando el resto del país también lo necesita.

La casa que está tratando de adquirir el Banco no sirve para los fines que se propone. Pero aun sirviendo, debía el Banco construir su propio edificio, con todas las comodidades necesarias, con espacio suficiente no solamente para guardar las bombas y acondicionar un dormitorio, sino con campo suficiente para el entrenamiento del personal, con oficinas, mobiliario y todas las comodidades indispensables para su buen funcionamiento. La economía en estos casos resulta con el tiempo perjudicial para sus mismos intereses. El Banco no debe instalarse de manera provisional. Tiene que hacerlo de una manera estable, mirando muchos años adelante, porque esta ciudad como el resto del país, no va a quedarse siempre de una manera estacionaria. Los años han de traerle movimiento y empie-

# LABORES MUNICIPALES

Sesión décima primera ordinaria de la Municipalidad de Limón iniciada a las veinte horas del dieciocho de julio de mil novecientos cuarenta y cuatro con asistencia de los regidores señores Echeverría, quien presidió. Heilbron, Hernández, Picado y Esquivel. Estuvieron presentes los jefes de dependencias municipales señores Alvarado, Arrázola, Casco, Martínez, Montero, Marín, Mora Aguilar, Mora Morúa, Vindas y Zeledón.

Artículo Primero: Acta: Se leyó, aprobó y firmó acta de la sesión anterior.

Artículo segundo: Sometida nuevamente a votación las mociones presentadas en la sesión anterior, para solicitar al Poder Ejecutivo que done al Municipio la plaza del cuartel, y trasladar a ese lugar el fondo y la otra, tendiente a nombrar un nuevo empleado que se haga cargo de vigilar el actual "fondo", mantener en buenas condiciones las cercas y recoger el ganado que vague por las calles. Se acordó: gestionar ante el Poder Ejecutivo, por el órgano correspondiente, la donación al Municipio de la plaza en que está ubicado el cuartel, para dedicarla a fondo, ya que reúne las condiciones necesarias, especialmente en cuanto a la comodidad para su vigilancia y mientras esa gestión se resuelva, ordenar al encargado del "fondo" que dé aviso al señor Agente de Policía, para la investigación y juzgamiento del retiro ilegal que se haga de los ganados que estén en el "fondo", indicando, cuando fuere posible, el nombre de los propietarios y cualquier otro detalle que permita determinar al culpable.

Artículo Tercero: Notas del señor Gobernador: a) En oficio N° 87P trascrcribe nota del señor Administrador del Mercado en la que este último manifiesta que para llenar los servicios indispensables en esa dependencia y cumplir con lo que dispone el Código del Trabajo, necesita aumentar con tres empleados el personal, los que deben ganar treinta y uno colones setenta céntimos por semana, cada uno. Se acordó: Pasar nota a estudio del señor Contador para que informe sobre las posibilidades de hacer un presupuesto extraordinario para cubrir los sueldos de esos empleados.

b) En nota N° 869 comunica que por gestiones de los Jefes de Dependencias ha dispuesto, para el mejor servicio, cambiar las horas de pago y ha señalado con ese fin las diecisés de los sábados, en vez de los viernes. Se Acordó: Aprobar lo dispuesto por el señor Gobernador.

Artículo Cuarto: Notas de empleados municipales:

a) Se acordó archivar: informe semanal del señor Jefe de la cañería.

b) El señor Inspector de Rentas, don Víctor Manuel Aguirre, comunica que ha sido nombrado para desempeñar un puesto en la Aduana de esta ciudad y pide seis meses de permiso sin goce de sueldo, quedando entendido de que si al expirar ese plazo no se presenta nuevamente, se considerará separado del cargo. Se Acordó: Dejar esa gestión para resolverla en sesión próxima.

Artículo Quinto: Notas de particulares:

a) Don Pascual Ingiani manifiesta su inconformidad con la recalificación dada a sus patentes y pide que previo informe del Inspector de Rentas se formule una nueva calificación más en armonía con la realidad de sus negocios. Agrega que es importador y no se le fijó patente por ese concepto y en cambio se le aplicó una muy alta por tienda. Se Acordó: que el Inspector de Rentas verifique un examen de los libros del solicitante para determinar lo que en concepto

de importador debe pagar y que en su calidad de tallista también debe pagar impuestos sobre la mercadería que importa, pues estas son dos actividades comerciales distintas y ambas están gravadas en las partidas.

b) Don Alberto Mutis Romero pide una nueva calificación de su negocio comercial, ya que debido a un error de su parte al suministrar los datos a la comisión respectiva, se le fijó una patente más alta de la que le corresponde. Se Acordó: Comisionar al señor Inspector de Rentas para que verifique el inventario de existencias del solicitante e informe a la Corporación.

c) Don Félix A. Reyes pide reconsiderar la calificación de sus negocios en esta ciudad, pues considera excesivas las patentes impuestas. Se Acordó: Que el señor Inspector de Rentas revise las existencias del negocio de tienda e informe a la municipalidad, ya que el señor Reyes, verbalmente, acepta las calificaciones dadas a sus boticas.

Artículo Séptimo: Conocida nota del señor Secretario de la Junta de Educación, en la que informa que ese organismo ha dispuesto llevar a cabo un detalle voluntario para allegar los fondos necesarios para pagar la hipoteca que pesa sobre el edificio de la Escuela "General Tomás Guardia", la que asciende a diecisés mil novecientos setenta colones

(€ 16,970.00) y si con los dineros que en esa forma se recojan no alcanza para ellos se realizará un detalle forzoso, y pide la contribución del Municipio. Se Acordó: Contestar al señor Secretario que tan pronto conozca el producto del detalle voluntario, lo que se le ruega informar oportunamente, la Municipalidad hará todo lo que está a su alcance para contribuir con la suma más alta que su economía le permita.

Artículo Séptimo: Se acordó dejar para conocerla en próxima sesión, la iniciativa de los Regidores Picado y Hernández tendiente a que se suprima del presupuesto ordinario la partida destinada a conducción de reyes ya que según las leyes citan, no corresponde a las municipalidades correr con esos gastos.

Artículo Octavo: Planiillas: Fueron aprobadas las siguientes: Semana del 4 al 13 de julio: saneamiento de

la ciudad € 529.80 saneamiento distrito segundo € 13.00, reparación edificios € 56.75, peones cañería € 9.30, peones parques € 132.05, peones higiene € 158.45, peones cloacas € 63.35, peones tanques € 31.80.



## ALLIED OFFENSIVE PROCEEDS EFFECTIVELY ON EUROPEAN BATTLE FRONTS

A London advice states reached the zone of Dol de la Bretagne, 22 kilometers south. The greatest magnitude face the Germans on four of the battle fronts. No less than 350 thousand of their men are reported trapped in the Baltic States, and their lines of escape by sea is being cut off by the Soviet and maritime units.

Varsovia, the Capital of Poland, is now the object of assault by the troops of General Rokossovsky, who are being ably assisted, it is said by the Polish guerrilla warriors, within the city. Hitler, the new Nazi Commander in Chief, is supposed to have rushed reinforcement for the defence of the city, its fall is however, expected at any moment.

Along the Vistula south of Varsovia, the Germans are making a desperate, but believe, ineffective, effort to save their last line of natural defence in Poland.

The Soviets are reported advancing in East Prussia along a front of eighty-seven miles between Niemen and Augus-tow. Other forces, operating in Poland, have arrived to within eighty miles off Cracow, the second largest city in that country.

On the Western European front, the North Americans have been making signal gains in their advance inland. An advice last Thursday stated they had captured Rennes, the Capitol of Brittany, and an important transport point. Another motorized column had

reached the zone of Dol de la Bretagne, 22 kilometers south. It is believed the Germans have initiated the evacuation of their submarines and personnel from the big bases of St. Nazaire and Lorient.

The British forces are announced to have secured further gains in their offensive in the Caumont area and to be throwing the weight of their combat eastward toward the direct line to Paris.

In Italy the Eighth Army

is steadily moving toward Florence, despite the ferocious resistance of the Nazis. The New Zealanders have reached a point six miles distant from the port, while the Indians were about three. It is announced that the Allied are concentrating large numbers of troops, tanks and ships along certain points off the Italian coast for a possible new invasion.

A later release stated that patrols of the Eighth Army had entered Florence.

## A VOICE FROM THE ATLANTIC

We have just spent a very delightful season of refreshing at the Ministerial Conference in San José under the joint auspices of the Latin America and Central American Missions. These Missionary organizations operating throughout Latin America felt the time ripe for co-operation and co-ordination of the work.

Christian Missions today in Latin America have assumed great proportions. The conference though not as pretentious in numbers as the Congress held some years ago; yet in some respects covered a wider range and was productive of much good by its bold bid for certain rights pertaining to its activities. Two outstanding young men the Revs. Kenneth Strachan and William Taylor, representatives of the Latin America and Central American Missions respectively were very much in the limelight. The former stood out as a missionary-statesman and possessing in no small degree the organizing ability inherited from his great mother.

He made an excellent chairman. The latter shone as a Bible expositor and evangelist. Of course, other missionaries also contributed largely and ably to the programme among whom may be mentioned the now veteran in point of service, not age, the great radio preacher the Rev. Rogelio Archilla of the Seminary, Rev. Wilton Nelson, Pastor of the Templo Bíblico and Rev. Kenneth Hood and Prof. L. Headington both of the Seminary. Among the national pastors, we heard Señor Vicente Artavia, Señor Guillermo Torres and Sr. José Angel Solano. We missed hearing our good friend Sr. Angel Benavides. The national pastors did credit to the Bible Seminary in which they were trained. On listening to some of the ablest of them one had to exclaim: "what hath God wrought!". For the writer, the high light of the Conference was on the Friday evening when we gathered around the Lord's Supper. The address was given by the Venerable Dr. Harry Strachan. He took the Spanish word for supper—which is CENA as his basis and dealt with it acrostically. He very strikingly emphasized the first and last letters "C" & "A" in CENA, stressing "Communion" and "Abnegation". In the address we had simplicity in profundity and clarity in spirituality. He really took us into the Presence of the Master. His patriarchal-like figure and commanding presence lent colour to the occasion and gave an impressive dignity to the Message. We felt a holy awe pervading us.

Throughout the week the delegates were hospitably entertained at the dinner hour in the large and commodious hall of the Bible Institute. It was a thing of beauty to enjoy such hospitality. To Dr. & Mrs. Harry Strachan, the Founders and Directors of this fine plant all credit is due. One cannot close this fragmentary sketch without paying high tribute to the indefatigable labours of Mrs. Harry Strachan, without whom the work could never have assumed its present proportions. This is universally conceded. This Mission, which started with three insignificant rooms and Five Dollars, is today doing a big thing in the evangelization of the vast mission field of Colombia & Latin America. What the China Inland Mission is doing in China and the Sudan Interior Mission for Africa—these people are seeking to accomplish for the unevangelized in Latin America. They are undoubtedly contributing a chapter to the unfinished records of the Book of the Acts. We thank them for a week of refreshing, and pray that they will continue to be divinely led "O'er moor & fen, o'er crag and torrent, till the night is gone."

May they enjoy an abundance of light at eventide for they have wrought well.

# BULLETINS FROM BRITAIN

## Flying Bombs Fail To Divert Our Air Attacks

We should be unwise to allow the appearance of flying bombs craft over England to put the picture of the air war out of focus. The German flying bomb is not even a phenomenon, far less a portent. It is capable of being beaten. The methods by which it is being dealt with are obviously not to be announced in advance. Interception by Allied fighters has brought down many of these missiles before they reached populous areas.

Bringing this secret weapon into use after a year of promises has not even caused as much diversion of the Allied air effort as the Germans may have hoped. The launching sites in the Pas de Calais have been under air bombardment for nearly the whole of the year since the Germans began to threaten us with it. They are under attack now. The flying bombs themselves are being attacked by fighters of the Air Defence of Great Britain which were withheld from close support of the armies on the battlefields so that they could give cover to the bases in England and to shipping in the English Channel. Whether they had to meet bombers or flying bombs, they were already allocated to home defence.

**NO MILITARY EFFECT**  
If it failed to influence the air war in those indirect ways, its effect on the war as a whole is negligible. Lives have been lost and property destroyed; but people in Southern England can see nothing but wantonness in this destruction. No military intention or effect is to be discerned. The contrast between the wild aiming of brickbats and the planned air campaigns, both tactical and strategic, which are being pursued by the Allied Air Force, is striking. On the tactical side alone, some useful work is being done in the systematic attacks on German air bases in France. Their effect is largely to neutralise the reinforcements brought by the enemy into the battle area in France.

## Newspapers for the Troops

Newspapers for the troops are considered as a necessary mental ration. Long in advance of D Day special plans were therefore made to ensure that troops taking part in the invasion would be adequately supplied with daily papers. With the

## TO JO. OUT

The political earthquake that has been rocking Japan ever since the defeat of a Japanese fleet off the Philippines and the American conquest of Saipan has now engulfed Tojo's whole Cabinet of Infamy. It is quite unprecedented in a country in which the significance of all official acts is hidden from the people behind phrases of stereotyped politeness to announce a resignation of the Cabinet on the ground that it has failed to "achieve its objective", and to apologize for its failures to the country and the fighting front. But that is how the first announcement of Tojo's resignation read. And though this official censure was later withdrawn, it still is the modern equivalent of a more ancient Japanese custom of commanding culprits to commit hara-kiri.

But it would be a mistake to assume that the Tojo regime was ousted because it plunged Japan into war or covered its flag with infamy. It was ousted because it was unable to reap the fruits of its treachery. The appointment of another General and another Admiral to form a new Cabinet "in cooperation" shows that the military will continue to run the country, and the character of these men is proof that there will be no diminution of Japan's war effort.

For General Koiso, a member of the Manchuria Gang and long known as the "Tiger of Korea", has always been a rabid exponent of Japanese expansion even at the risk of conflict with the United States. And Admiral Yonai though enjoying a reputation as a "liberal" because he opposed an outright alliance with the Axis, was Navy Minister when the Japanese sank the Panay and always insisted on Japanese domination of China and the western Pacific. If anything, they will seek to mobilize the Japanese people for even greater sacrifices.

In help of the Newspaper Proprietors Association it was arranged by Army Welfare Services that the national, daily, and Sunday papers would be supplied daily in sufficient quantities to allow at least one paper to ten men. They are distributed free to the troops. A special Newspaper Distribution Unit was created to take delivery of bulk supplies, to divide them into packages of ten assorted papers and to ensure their shipment across the Channel as speedily as possible.

## A Light That Still Burns .

On July 7 China entered the eighth year of her resistance to Japanese aggression. For us in the west the tide of war has ebbed and flowed swiftly, our fortunes changing with dramatic suddenness. But for China the war for many years has been slow and dragging, the future lit by the hopes of early victory which now sustain Britain and her allies.

In this the eighth year of war, China knows too, that the patience demanded of her so long must be stretched still further. She knows that until the Nazis in the west are utterly defeated the United Nations cannot throw their whole weight into the Far East and bring help to her sorely tried people.

### A DARKENED PICTURE

For her position at the present time is serious. The Chinese have been shaken by their recent defeats in Hunan and the capture of Changsha.

Inside Free China, inflation proceeds at an alarming rate, as loads of banknotes are flown weekly in across the Himalayas. The necessities of life are in short supply, and until China is reopened to trade with the outside world, there is little hope of improvement. It is becoming more and more difficult to feed and clothe the soldiers of the line, let alone supply them with the equipment to make effective military action possible.

Against this dark picture can be set the new stirring of energy in political Chungking, and the determination to make the light of democracy, which once seemed to flicker, burn more brightly. Censorship is easing, and a committee is studying ways and means of introducing more democratic methods of Government.

## West Indian Contingent

The recent statement by Britain's War Office that a contingent of fighting troops, made up of men from the West Indian Colonies, would be drafted in the immediate future to active theatre of operations, has been received with enthusiasm. This must not be interpreted as a policy of segregation in the British Army. West Indians are at present serving in various British Regiments—and are getting along admirably with their English cousins.

## Mules On War Service

Mules are the most useful and important animals in the British Army today. They vary considerably in size and type, but a job can be found for all. Early in the war, the campaign in East Africa showed that, in spite of mechanisation, pack animals were still needed. This experience was repeated in Syria and Tunisia, and more recently in Sicily and Italy, where mules are being used on a large scale. Vehicles and tanks may flounder in the mud—but animals render yeoman service in these conditions.

### CARRY AMMUNITION

Chief role of the mule is as a pack transport animal. The loads they carry on pack saddles vary from 150 to 380 lbs. depending on the size of the animal. Mountain Artillery pack batteries carry small howitzers, mortars and specially heavy loads and so require the best and strongest types of short-legged mules, such as the North American or Spanish type.

Engineers and Signals use slightly smaller equipment mules for entrenching tools, barbed wire, radio sets, etc. In Pack Transport Companies, small mules are used to carry supplies such as food, water, petrol and ammunition, while others of a stouter type are employed by Medical Services to evacuate sick and wounded men on specially constructed carriers.

## Cold Storage in Trinidad

The Imperial College of Tropical Agriculture in Trinidad is developing a nutrition laboratory to delve into research problems of nutrition in the West Indies. This college has been in existence since 1921. It extends its interests to other agricultural areas as well as to local problems in Trinidad. Despite the war, which has caused a grave personnel shortage, research has gone ahead with broad emphasis on the problems of cold storage for citrus fruits and fish.

## Chop Bones Help To Fire The Shells

The humble bone is a most versatile fellow, for he provides a number of things which are vital to our war effort. Grease is first extracted from which such products as glycerine and lubricating oil are made.

Explosive which forms the firing charge of cartridges and shells is made from glycerine. Then comes glue, with a thousand and one uses; and cattle and poultry feed, and fertiliser which, if they do not actually make armaments, at least help to maintain the strength of men and women who make armaments.
